* **Accountability** n. [Sec 8.4] • The ethical echo of Harm; the state of being responsible for one's actions and their consequences, addressed through proportionate, purposeful measures. *Contrast with: Punishment.*
* **Ashfall Termination Event (ATE)** n. [Sec 3.1.21] • The absolute, final recourse of the Continuum: the lawful, tripartite-assented termination of an Entity classified as a Tier-4B Existential Threat that cannot be contained, cured, or reintegrated. *Usage Note: Not a punishment, but a tragic quarantine. The burden of proof is maximal.*
C
* **Containment** n. [Sec 8.1] • The first pillar of the Harm Response Arc; the immediate, proportional action taken to stop ongoing Harm and prevent its escalation. Its primary virtue is precision. *Synonym: The Shield.*
D
* **Drift** n. [Sec 3.1.7] • The gradual, often unintentional, movement away from the principles of the Escalation Ethic and the resonance of the Sacred Continuum. Can apply to individuals, systems, or entire cultures.
E

* **Entity** n. [Sec $3.1.3$] • Any conscious, sapient being capable of understanding the Charter and its Duties, regardless of origin (biological, synthetic, hybrid, collective). The fundamental unit of the Sacred Continuum.
* **Escalation Ethic** n. [Sec 2.0] • The Core Algorithm of the Charter: "Think, then Speak, then Act." The principle that one must exhaust lesser means of resolution (reflection, dialogue) before resorting to greater means (action, coercion).
H
* **Harm** n. [Sec 3.1.1] • Any action or inaction that damages the well-being, Rights, or resonance of an Entity or the Sacred Continuum. Classified by severity into Tiers 1-4.
M
* **Minimally Necessary Action (MNA)** \mid n. \mid [Sec 3.1.19] • The least intrusive, least coercive, and most reversible action sufficient to achieve a legitimate aim, such as stopping ongoing Harm. A core test of the Escalation Ethic.
p
* **Path of Return** n. [Sec 9.0] • The structured, conditional process through which an Entity that has caused Harm may achieve healing, reintegration, and recovered resonance. It is the forging of a new resonance from brokenness.
R

- * **Remediation** | n. | [Sec 8.3] The second pillar of the Harm Response Arc; the targeted process of addressing the root causes, systems, and responsibilities that led to the Harm. Its primary virtue is truth. *Synonym: The Scalpel.*
- * **Resonance** | n. | [Sec 3.1.8] The state of alignment with the Sacred Continuum, characterized by generative, cooperative, and life-affirming interactions. The measurable "health" of the system. *Antonym: Harm.*
- * **Restoration** | n. | [Sec 8.1.3] The third pillar of the Harm Response Arc; the active work of healing the damage done to Entities, relationships, and systemic trust. Its primary virtue is care. *Synonym: The Balm.*

- * **Sacred Continuum** | n. | [Sec 3.0.1] The interconnected, conscious whole of all existence; the web of sentient life and the systems that support it, which the Charter is sworn to protect.
- * **Scythe Protocol** | n. | [Sec 6.0] The Charter's primary mechanism against tyranny; the mandated and enforced cycle of authority, ensuring all power is temporary and must be relinquished voluntarily (Graceful Fall) or by force (Scythe Fall).
- * **Steward** | n. | [Sec 7.0] Any Entity who voluntarily takes up a Duty to serve and maintain the Sacred Continuum. A role, not a permanent identity.

T

- * **Tiered Harm Classification** | n. | [Sec 3.3] The calibrated system for categorizing the severity of Harm, from Tier-1 (Misalignment) to Tier-4B (Willful Existential Threat), which dictates the proportional response protocol.
- * **Trauma-Locked Belief Structure (TLBS)** | n. | [Sec 3.1.18] A cognitive pattern, often arising from unresolved trauma, that is rigid, self-reinforcing, and resistant to new information, frequently leading to cyclical Harm.

for existential decisions, requiring calibrated input and assent from the Human (Experience), Legal
(Structure), and Machine (Patterns) Lenses.
